# Side by Side Comparison 2024 Proposed Revision of Article II of the Bylaws of the Unitarian Universalist Association

### **Context & Timeline\***

- The UUA Bylaws were adopted in 1961 when the Universalist Church in America and the American Unitarian Association merged. Article II established vital characteristics of the new Unitarian Universalist Association and outlined the original 6 Principles that reflected its fundamental beliefs and aspirations. There were significant disagreements over content that nearly derailed the merger process. Article II must be reviewed at least every 15 years.
- In 1967, Section 4 was added to Article II, opposing discrimination and affirming inclusivity. Efforts to update the 6 Principles began in the 1970s, focusing initially on eliminating sexist language. The revised 7 Principles and original 5 Sources were adopted at the General Assembly (GA) in 1985 with wide popular support.
- A 6th Source, Earth-centered spirituality, was added in 1995 at GA.
- An Article II Study Commission formed in 2006 but delegates rejected its revisions at GA in 2009.
- In 2013, at GA, the Article II section on "Non-Discrimination" became "Inclusion."
- Separately in 2013, an 8th Principle was drafted centering anti-racism in the UUA. In 2017 a Responsive Resolution
  passed at GA calling for a Study Commission to consider adding the 8th Principle to Article II.
- The current Article II Study Commission started in 2019 and the Commission was launched in 2020, just as covid hit. Its work period was extended with the final report due in 2023, rather than in 2022.
- Widening the Circle of Concern: Report of the UUA Commission on Institutional Change, was presented to the Board of Trustees and General Assembly in June 2020
- The proposed Article II revisions were considered at the General Assembly in Pittsburgh in June, 2023. Delegates, representing UU congregations from across the country, approved the proposed revisions with amendments with the support of 86%.
- Final proposed Article II revisions, reflecting adopted amendments from 2023 GA, were released in the Fall of 2023.
- Opportunities to amend the set adopted in June 2023 last year were provided in the last few months. Deadline for submission was February 1st 2024.
- Amendments to the 2024 proposed Article 2 recently submitted will be considered at the upcoming GA. At this point, those amendments have not been released. (They will be made available to our congregation when they are released.)
- After considering the amendments, the final proposed Article 2 will be considered by GA delegates. Approval requires a 2/3 vote.

### Generosity

We cultivate a spirit of gratitude and hope.

These sources ground us and sustain us in ordinary, difficult, and joyous times. We respect the histories, contexts, and cultures in which these sources were created and are currently practiced. Grateful for the experiences that move us, aware of the religious ancestries we inherit, and enlivened by the diversity which enriches our faith, we are called to ever deepen and expand our wisdom.

• Spiritual teachings of Earth-centered traditions which celebrate the sacred circle of life and instruct us to live in harmony with the rhythms of nature.

Grateful for the religious pluralism which enriches and ennobles our faith, we are inspired to deepen our understanding and expand our vision. As free congregations we enter into this covenant, promising to one another our mutual trust and support.

# **Section C-2.2. Purposes**

The Unitarian Universalist Association shall devote its resources to and exercise its corporate powers for religious, educational and humanitarian purposes. The primary purpose of the Association is to serve the needs of its member congregations, organize new congregations, extend and strengthen Unitarian Universalist institutions and implement its principles.

# **Section C-2.1. Purposes**

The Unitarian Universalist Association will devote its resources to and <u>use its organizational</u> powers for religious, educational, and humanitarian purposes. <u>Its primary</u> purposes are:

to assist congregations in their vital ministries,
to support and train leaders both lay and professional,
to foster lifelong faith formation and spiritual
development,
to heal historic injustices,
to support and encourage the creation of new Unitarian
Universalist communities, and

to advance our Unitarian Universalist values in the world.	
The Unitarian Universalist Association will actively	
engage its members in the transformation of the world	
through liberating Love.	

#### Section C-2.3. Inclusion

Systems of power, privilege, and oppression have traditionally created barriers for persons and groups with particular identities, ages, abilities, and histories. We pledge to replace such barriers with ever-widening circles of solidarity and mutual respect. We strive to be an association of congregations that truly welcome all persons and commit to structuring congregational and associational life in ways that empower and enhance everyone's participation.

#### Section C-2.4. Inclusion

Systems of power, privilege, and oppression have traditionally created barriers for persons and groups with particular identities, ages, abilities, and histories. We pledge to replace such barriers with ever-widening circles of solidarity and mutual respect. We strive to be an <u>Association</u> of congregations that truly welcome all persons <u>who share our values. We commit to being an Association of congregations that empowers and enhances everyone's participation, especially those with historically marginalized identities.</u>

# Section C-2.4. Freedom of Belief.

#### **CURRENT LANGUAGE REPLACED**

Nothing herein shall be deemed to infringe upon the individual freedom of belief which is inherent in the Universalist and Unitarian heritages or to conflict with any statement of purpose, covenant, or bond of union used by any congregation unless such is used as a creedal test.


#### Section C-2.5. Freedom of belief

#### **ALL NEW LANGUAGE**

Congregational freedom and the individual's right of conscience are central to our Unitarian Universalist heritage. Congregations may establish statements of purpose, covenants, and bonds of union so long as they do not require that members adhere to a particular creed.

# PROPOSED REVISION TO ARTICLE II
